Commission Work Programme 2022. The European Commission adopted it designed to rebuild a post COVID-19 Europe, accelerate the twin green and digital transitions, and build a fairer and more resilient society. The political strategy of this Commission is to set Europe on a path to successfully achieving climate neutrality by 2050, shaping our digital future, strengthening our unique social market economy, building a Union of prosperity, and making Europe stronger in the world. This work programme sets out targeted action to complete delivery on the ambitions the Commission set at the start of the mandate and further steer the Union towards sustainable recovery. It also lists the key legislative proposals that should get priority in the legislative process. To minimise the burden linked to the successful achievement of EU policy objectives, the Commission Work Programme initiatives will follow the 'one-in, one-out' approach. The approach will ensure that when introducing new burdens, we will systematically and proactively seek to reduce burdens for citizens and businesses in the same policy area and present costs, where feasible and proportionate. The purpose is to make sure that EU legislation delivers concrete benefits while alleviating administrative burden on EU citizens and businesses, especially small- and medium-sized enterprises. resource.html (europa.eu)

EU and US agree to start discussions on a Global Arrangement on Sustainable Steel and Aluminium and suspend steel and aluminium trade disputes. Steel and aluminium manufacturing is one of the highest carbon emission sources globally. For steel and aluminium production and trade to be sustainable, they must address the carbon intensity of the industry, together with problems related to overcapacity. The Global Arrangement will seek to ensure the long-term viability of our industries, encourage low-carbon intensity steel and aluminium production and trade, and restore market-oriented conditions. The arrangement will be open to all like-minded partners to join. Furthermore, following the United States' announcement that they will remove Section 232 tariffs on EU steel and aluminium exports up to past trade volumes, the European Union will take the steps to suspend its rebalancing measures against the United States. The two sides have also agreed to pause their respective WTO disputes on this issue. *EU-US Trade Relations on steel and aluminium EU-US Joint Statement (europa.eu)*

Impact of trade chapters of the Euro-Mediterranean Association Agreements with six partners: Algeria, Egypt, Jordan, Lebanon, Morocco and Tunisia. The Commission published the Staff Working Document on the evaluation of the Euro-Med FTAs with six Southern-Mediterranean countries: Algeria, Egypt, Jordan, Lebanon, Morocco and Tunisia. The Commission Staff Working Document concludes that the Euro-Med FTAs have achieved their objectives and had positive effects on trade, GDP, welfare, consumers and workers in both the EU and the Southern Neighbourhood. However, there are areas for improvement, such as non-tariff measures, enhancing regulatory cooperation, reinforcing Euro-Med FTAs implementation or achieving the sustainability objectives in the FTAs. In line notably with the Communication on Trade Policy Review and the Joint Communication on Renewed Partnership with the Southern Neighbourhood, there is readiness to further modernise EU's trade and investment relations with interested partners in the Southern Neighbourhood, to better adapt them to today's challenges. https://eur-lex.europa.eu/legal-content/EN/TXT/PDF/?uri=CELEX:52021SC0319&from=EN

<u>Launch of new intellectual property helpdesk service for European SMEs doing business in Africa</u>. Africa IP SME Helpdesk is a service implemented by the European Union Intellectual Property Office (EUIPO). One of the biggest

concerns for European SMEs trading with or investing in international markets is how to protect and enforce their IP outside of the EU. To help companies tackle this challenge, the Africa IP SME helpdesk offers free-of-charge, first-line IP support to European SMEs already operating in or planning to do business in Africa. The service comprises a set of support actions including a jargon-free, tailormade and confidential helpline to answer questions on IP and related issues, as well as web-based training sessions, information materials, and online resources. EU launches International Just Energy Transition Partnership with South Africa. The governments of South Africa, France, Germany, the United Kingdom, the US and the EU have announced a new ambitious Just Energy Transition Partnership to support South Africa's road to decarbonisation. The Partnership will mobilise \$8.5 billion for the first phase through grants, loans and investments and funds from the private sector. The aim is to accelerate the decarbonisation of South Africa's economy, with a focus on transforming its electricity system. It is expected to prevent up to 1-1.5 gigatonnes of emissions over the next 20 years and support South Africa's transition from coal to a more resilient climate model. <u>Just Energy Transition Partnership with South Africa (europa.eu)</u>

Commission collects views on making liability rules fit for the digital age, Artificial Intelligence and circular economy. The Commission has launched a public consultation until 10 January on the rules on compensation for damage caused by defective products. A specific focus will be on the use of Artificial Intelligence (AI) in products and services. The Commission invites interested parties to express their views on the revision of the <u>Product Liability Directive</u> and on whether other national liability rules still provide legal certainty and consumer protection in an age of smart and AI-based products and services. This is especially important since the safety of these products and services does not depend only on their design and production, but also on software updates, data flows and algorithms. *Civil liability – adapting liability rules to the digital age and artificial intelligence (europa.eu)*

An analysis of SMEs' needs in public procurement. The objective of this study is to improve the participation of small and medium-sized enterprises (SMEs) in public procurement. It identifies support actions to reduce the barriers SMEs face and to communicate the opportunities offered to them by public procurement. Being a public sector supplier with long-term contract commitments may shield a company against recession. Moreover, as subcontractors of larger firms in public procurement, SMEs could increase their business opportunities while reducing cash flow volatility and other risks. The strong involvement of SMEs in public procurement also allows contracting authorities to considerably broaden their potential supplier base and benefit from more competition for public contracts. The aim is to produce research results that can be implemented by CEDR members and contribute to a safe, sustainable and efficient road network across Europe. It is funded by CEDR members on a voluntary basis. Participation is open to any legal entity, though all consortia must be led by a legal entity from a European country. <u>Latest statistics on EU jobs and the EU exports published: a 75% increase in two decades</u>. The Commission released the Report on Trade and Jobs, a new report that provides a host of statistics on the European jobs connected to European exports. It shows how important trade has become for European jobs, with EU exports currently

supporting over 38 million jobs. <u>Industry enterprises: largest share of trade value</u>. In 2019, at EU level, even though enterprises from the industry sector only made up about 15% of the total number of importing enterprises, industry's share in the value of imports was 47% - the highest among the 3 categories in 2019. It was the same for exports; the enterprises forming part of the industry sector accounted for 73% of the value of exports, although they only represented 27% of the total number of exporting enterprises. <u>Database - International trade in goods - Eurostat (europa.eu)</u>
